# **Keeping tab on US Fed**

### Market Review & Outlook

- **Malaysia Market Review**. The FBM KLCI (+1.3%) finished sharply higher, driven by the dovish remarks over interest rate direction from the US Federal Reserve. The lower liners also advanced, while the Financial services sector (+1.4%) outperformed the mostly positive sectorial peers.
- **Global Markets Review**. Wall Street extended its lead on growing expectations that the US Federal Reserve may take another step back on the interest rate hike. Both the European and Asia stock markets closed upbeat.
- **Market Outlook**. The recent pullback appears to be at tail end with signs of a change in direction on the local bourse as of late. We reckon that upside prevails with investors nibble onto beaten down stocks. The lower liners are also poised for an extended recovery, on the back of the calmer market conditions. Going forward, the US PPI data to be release tonight will be watched closely with consensus pointing towards another month of miniscule expansion, while the FOMC minutes meeting will be in focus. We reckon that the technology sector may mirror the positive developments on Nasdaq overnight.

 Technical Commentary: The FBM KLCI formed a bullish candle to close above the daily EMA20 level yesterday. We reckon an extended recovery may lift the key index to take another jab towards SMA200. Indicators, however, remained mixed as the MACD Line continues to hover below the Signal Line, while the RSI treads marginally below 50. With the near-term resistance of 1,424 taken out, the key index may head towards the next resistances located around 1,438-1,464. Support is set around 1,413.



### **Company News**

- **Bina Puri Holdings Bhd** announced that its wholly owned subsidiary Bina Puri Sdn Bhd (BPSB) has been served with a winding-up petition from the lawyers of Thai Soon Hang (Sabah) Sdn Bhd at the High Court of Sabah and Sarawak, due to a default payment amounting to RM198,116.60.
- **Sarawak Cable Bhd** faces a similar situation, with subsidiaries Leader Cable Industry Bhd and Universal Cable (M) Bhd receiving winding-up petitions served by OCBC Bank (M) Bhd on Oct 9.
- **PTT Synergy Group Bhd** has entered into a sale and purchase agreement (SPA) to acquire two parcels of freehold development land for RM70.56 million via indirect wholly-owned subsidiary Projek Tetap Teguh Sdn Bhd (Projek TT) on Tuesday.
- **LKL International Bhd**, whose share price has halved since the start of the year, is selling a parcel of land in Serdang, Selangor for RM6.65 million.
- **Digistar Corp Bhd** is selling two parcels of freehold land in Melaka for RM7.76 million cash.
- **Focus Lumber Bhd** announced that it has entered into an industrial tree planting agreement (ITPA) with Rakyat Berjasa Sdn Bhd (RBSB) to plant, rehabilitate and harvest forests in a 5,000-hectare area in Sabah's Sungai Pinangah Forest Reserve.
- **ITMAX System Bhd** has secured a RM79.6 million contract from the Pasir Gudang City Council in Johor to design, install and maintain a smart command centre, a closed-circuit camera system with artificial intelligence (AI) features as well as a smart traffic lights system within the district.
- **Kerjaya Prospek Group Bhd** has bagged a RM226 million contract from Aspen Vision City Sdn Bhd for the development of a 37-storey residential building in Batu Kawan, Penang.
- **Perak Transit Bhd** has secured approval from the Ministry of Finance (MOF) for an investment tax allowance (ITA) on qualifying capital expenditure in relation to the development of an integrated public transportation terminal in Bidor, Perak.
- Khazanah Nasional Bhd via its associate Pulau Kapas Ventures Sdn Bhd (PKV) has disposed of its 3.7% stake, equivalent to 67.5 million shares, in **TIME dotCom Bhd**, whose share price climbed to an all-time high of RM5.56 last week.
- **Sapura Energy Bhd** said the contract for the engineering, procurement, construction and installation (EPCI) of the single buoy mooring (SBM) Pipeline Rejuvenation Phase II Project in Singapore has been terminated.
