Technical Commentary:

Price broke the downtrend formation since July 2022. Following the rebound, price subsequently breached the EMA120 and tested the SMA200. MACD is rising above its signal line in the positive territory while the RSI is climbing towards the oversold region. Resistances are set at **RM0.24-0.255**. Support is pegged at **RM0.20**.

MACD has just cut above the signal line and heading towards positive territory, while the RSI risen above 50. Resistances are at **RM1.20-1.24.** Support is located at **RM1.06.**
