# **Treading within consolidation**

## Market Review & Outlook

- Malaysia Market Review. The FBM KLCI (-0.18%) extended its decline with oil & gas and plantation giants retreating following the weaker commodity prices. The lower liners also extended their pullback, while the healthcare sector (+1.87%) outperformed the mostly negative sectorial peers.
- **Global Markets Review**. Wall Street was closed in conjunction with the Thanksgiving public holiday, while futures markets are pointing towards a positive opening. European stock markets traded mildly higher as European bonds fell after Germany suspended debt limits for the fourth straight year, but Asia stock markets closed mixed.
- Market Outlook. Once again, we opine that the FBM KLCI may continue to tread on a downward bias consolidation band in view of the lack of fresh leads, coupled with the closing of US stock markets overnight. The downturn of Eurozone's business activity is stoking concern over potential recession, which may trigger further volatility. Back home, investors will be keeping a close watch onto Malaysia's inflation data to be release today. At the same time, the preliminary reading of US S&P Global Manufacturing PMI data will be in focus.

• **Technical Commentary**: The FBM KLCI declined for a second day but remained sideways above the SMA50. Indicators were flat as the MACD Line hovered above the Signal Line, while the RSI moved sideways above 50. The benchmark index could remain sideways below the resistance of 1,465. Support is pegged around 1,435.

- **Genting Bhd** saw its net profit jump by over four-fold to RM520.52 million for the third quarter ended Sept 30, 2023 (3QFY2023).
- **Genting Malaysia Bhd** (GenM) recorded a net profit of RM177.41 million or 3.13 sen per share for the third quarter ended Sept 30, 2023 (3QFY2023), the group's highest quarterly profit since the Covid-19 outbreak in 1QFY2020.
- **Syarikat Takaful Malaysia Keluarga Bhd** (Takaful Malaysia) posted a 24.9% increase in net profit for the third quarter ended Sept 30, 2023 (3QFY2023) to RM91.1 million.
- **Jentayu Sustainables Bhd** is disposing of a 12,884 sq ft piece of residential land in Jalan Mayang here to Armani Development Sdn Bhd for RM25 million.
- **Kanger International Bhd** said it is acquiring the remaining 49% stake in building materials supplier Sung Master Holdings Sdn Bhd for RM72 million cash.
- **S P Setia Bhd** has reported that its net profit for the third quarter ended Sept 30, 2023 fell to RM51.8 million from RM70.19 million in the same quarter of 2022.
- **AME Elite Consortium Bhd** posted a 52.34% drop in its second quarter net profit ended Sept 30, 2023 (2QFY2024) to RM21.83 million.
- Allianz Malaysia Bhd's net profit grew 42% year-on-year for the third quarter ended Sept 30, 2023 (3QFY2023) to RM197.86 million.
- **DRB-Hicom Bhd** registered a 50.8% drop in net profit to RM70.8 million in the third quarter ended Sept 30, 2023 (3QFY2023).
- **Petronas Dagangan Bhd** (PetDag) said its net profit for the third quarter ended Sept 30, 2023 (3QFY2023) declined 33.06% to RM184.72 million.
- **Dayang Enterprise Holdings Bhd** posted its best quarterly net profit in about three years after the integrated oil and gas service provider logged a net profit of RM76.38 million for its third quarter ended Sept 30, 2023 (3QFY2023).
- **YTL Corp Bhd** posted its best quarterly net profit since 2006 at RM521.7 million in the quarter ended Sept 30 (1QFY2024).
- **Petron Malaysia Refining & Marketing Bhd**'s net profit surged 155.17% to RM81.9 million in the third quarter ended Sept 30, 2023 (3QFY2023).
