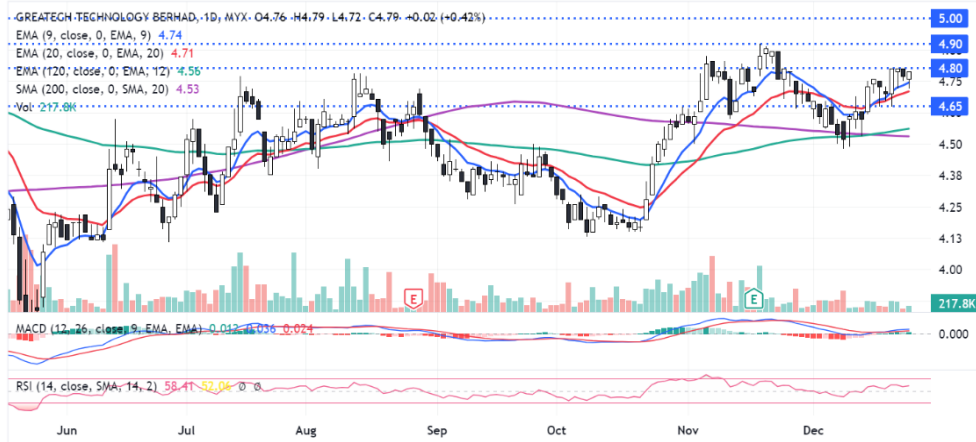

Traders may anticipate for a potential short-term breakout above RM4.80 to target the resistance levels located at **RM4.90-5.00**. Downside wise, support is pegged at **RM4.65**.
