Technical Commentary:

Price climbed gradually from a low of RM1.30 in October 2023 to break the downtrend channel since May 2023. Price has formed a bullish candle to surge and retested SMA200. Traders may anticipate for further upside with the next resistance levels located at **RM1.41-1.48**. Downside wise, support is pegged at **RM1.35**.
