Price tested the the EMA120 yesterday after forming a bullish candle. Indicators are mixed with the MACD hovering above the Signal Line while the RSI is climbing towards the overbought zone. Should share price climb above EMA120, price could spark a rebound towards the resistance levels of **RM0.985-1.08**. For the downside, support is at **RM0.87**.
