## Still sideways

### Market Review & Outlook

- **Malaysia Market Review**. The FBM KLCI (-0.87%) was bearish on last Friday with 24 index components falling as the key index bucked the mostly positive regional trend. The lower liners were also negative across the board except for Healthcare (+0.18%) and Plantation (+0.41%) sectors, while Construction sector (-2.68%) was the worst performer.
- **Global Markets Review**. Wall Street finished strongly on last Friday with the Nasdaq and S&P climbing to fresh record highs, led by technology behemoths such as Nvidia and Meta Platforms. Both the European and Asia stock markets were also bullish on last Friday.
- Market Outlook. We expect the FBM KLCI to remain sideways at the moment after failing to beat the recent high of 1,560. The lower liners may attempt to find stability following the recent pullback with investors nibble onto the recent beaten down stocks. With the conclusion of quarterly earnings growth, the key focus will focus towards economic data. Regionally, investors will be monitoring on developments over the 14th National People's Congress (NPC) in China to provide guidance over the world second largest economic health. We continue to favour the technology sector that is expected to mirror the positive performance on Nasdaq that surged to a record high. Also, the energy sector will be in focus after crude oil prices touched US\$80 per barrel ahead of OPEC+'s decision on production cuts.

 Technical Commentary: The FBM KLCI rose 0.38% to rebound from Wednesday's plunge with 17 component stocks rising yesterday. Indicators were mixed as MACD Line crossing below Signal Line, while RSI was sideways above 50. After Wednesday's pullback, the FBM KLCI could remain sideways below resistance of 1,570. Meanwhile, immediate support is pegged at 1,540.

- **KUB Malaysia Bhd's** wholly owned subsidiary KUB Agro Holdings Sdn Bhd (Kubah) is acquiring the 40% equity interest in KUB Sepadu Sdn Bhd (KUBS) not in its control from Medan Sepadu Sdn Bhd and Lembaga Amanah Kebajikan Kaum Melanau Sarawak for RM60 million.
- **Sapura Energy Bhd** said a Mexican unit of the group has been declared bankrupt, after it had failed to restructure its debts with creditors within the stipulated time frame given by a court in that country.
- **Kumpulan Jetson Bhd** has initiated a legal action against requisitionists of a failed attempt to call for an extraordinary general meeting to remove the entire board of directors of the construction group.
- **Pekat Group Bhd** is selling an industrial freehold land, measuring 12,813.89 sq m, for RM21 million cash, to realise the value of the unused property, with proceeds from the sale to be used for working capital.
- Orgabio Holdings Bhd has appointed Ean Yong Hian Wah, the chairman
  of the Port Klang Authority (PKA), as its executive chairman with
  immediate effect.
