Embracing renewed volatility

Market Review & Outlook

- Malaysia Market Review. The FBM KLCI (-0.15%) was slightly lower with 20 losers against 9 gainers among its component stocks yesterday. The lower liners were remained negative while the Construction and Technology sectors rebounded as the top performing sectors. Meanwhile, the Plantation sector was the worst performer.
- **Global Markets Review**. Wall Street extended its decline on weakness in technology megacaps such as Apple, Advanced Micro Devices and Tesla on mounting concerns over sky-high valuations. Both the European and Asia stock markets were mostly bearish yesterday.
- Market Outlook. We expect the FBM KLCI to remain downbeat that may mirror the negative performance on Wall Street overnight. The lower liners are also bracing for more volatility on an extended pullback from their recent high levels. Renewed volatility on Wall Street is deemed to be healthy which allows recent gains to be digested and valuations may subsequently turn more compelling. Looking ahead, investors will be keeping a close tab onto US Federal Reserve Chair Jerome Powell testifies to the Congress in search for clues over the future interest rate direction. We favour gold-related stocks after gold prices advanced to hit all-time high levels in anticipation of monetary easing, escalating geopolitical tension and rising risk of equities market pullback amid the lofty valuations.

 Technical Commentary: The FBM KLCI formed a hammer candlestick pattern, indicating a potential end to the price decline and a forthcoming upward price move. Indicators remained mixed as MACD Line crossing below Signal Line, while RSI was sideways above 50. With the slightly negative momentum, the FBM KLCI could remain sideways below resistance of 1,570. - Iskandar Waterfront Holdings Sdn Bhd (IWH) and PLS Plantations Bhd, two entities linked to tycoon Tan Sri Lim Kang Ho are in talks with a China state-owned company to develop an industrial park and innovation hub in Johor.
- Solarvest Energy Sdn Bhd, a subsidiary of clean energy expert Solarvest
 Holdings Bhd, has been appointed by Gentari Renewables Sdn Bhd to
 install solar power systems at over 300 Petronas stations across Malaysia.
- Crest Builder Holdings Bhd's order book has reached a record high of RM1.8 billion after the group bagged a commercial development in Kuala Lumpur from Sunway Velocity Three Sdn Bhd for a total contract value of RM448.5 million.
- **Paramount Corp Bhd** aims to sell RM1.4 billion worth of properties in the financial year ending Dec 31, 2024 (FY2024), as the company ramps up launches worth RM2.4 billion in gross development value for the year, including some delayed projects.
- PPB Group Bhd, which operates Golden Screen Cinemas (GSC), said it
 expects a tough year ahead for its film exhibition and distribution business,
 as the Hollywood writers' guild strike has affected supply of content in the
 medium term.
- Petroliam Nasional Bhd (Petronas) and CIMB Islamic Bank Bhd have signed an inaugural Tahawwut Master Agreement (TMA) for shariahcompliant commodity derivatives.
- Nextgreen Global Bhd has proposed a private placement of up to 102.57 million shares, representing 10% of its issued share capital, to yetto-be-identified third-party investors with the issue price to be determined later.
- **Fajarbaru Builder Group Bhd** has won a RM120.82 million contract to build a clubhouse and a driving range complex in Johor Bahru.
