Price bounced off the SMA200 to reclaim the EMAs 9,20,120. Price could extend its uptrend since December should SMA200 manages to hold. Traders may monitor for a potential rebound towards the resistances located at **RM0.83-0.865**. Downside wise, support is pegged at **RM0.755**.
