Price is still on the uptrend formation despite choppiness prevails. After bouncing off EMA120 in April 2024, price advanced before consolidating in recent months along EMA20. Traders may anticipate for a potential short-term triangle breakout above RM0.94 to target the next resistances located at RM0.96-0.975. Downside wise, support is pegged at RM0.915.
