Price has turned into a multi-month long of consolidation. Coming closer, price has recovered above EMA20 and the uptrend formation was established. Price has experienced a flag-formation breakout above RM2.24 and may advance to target the next resistances located at **RM2.54-2.73**. Downside wise, support is envisaged at **RM2.07**.

Since then, price staged a v-shaped rebound above EMA120 but the recovery were kept short before price staging a mild pullback. With price attempting to find stability, traders may monitor for a potential triangle formation breakout above RM0.875 to target the next resistances located at **RM0.95-1.03**. Downside wise, support is pegged at **RM0.815**.
