Price is still on the uptrend formation and largely supported above EMA20 in recent months. Following the recent mild pullback, traders may anticipate for a potential flag-formation breakout above RM1.21 to target the next resistances located at **RM1.25-1.30**. Downside wise, support is envisaged at **RM1.12**.
