Price has formed a retracement since peaking in late-July. After bouncing off EMA120, price appears to have found stability. Coming closer, price has formed a bullish candle to breakout above RM1.39 and closed above EMA20. Price may advance to target the next resistances located at RM1.58-1.77. Downside wise, support is envisaged at RM1.31.
