Technical Commentary:

Price has staged a sharp rally in late August before cooling off in recent month. After briefly dipping below EMA20, price is now attempting to find stability with several bullish candles formed in recent days. For now, traders may anticipate for a potential trendline breakout above RM2.49 to target the next resistances located at RM2.58-2.68. Downside wise, support is envisaged at RM2.34.
