Market Review & Outlook

- **Malaysia Market Review.** FBM KLCI closed 0.4% up on Wednesday, lifted by utilities heavyweights. Lower liners were also broadly up for the day. Apart from the Construction sector that was flat, all the other sectors ended the day green. The Technology sector (+2.6%), Healthcare sector (+2.1%) and Energy sector (+2.0%) topped the gainers.
- **Global Markets Review.** In Wall Street, all three major indices closed green. S&P 500 (+0.6%), Nasdaq (+1.3%) and the Dow (+0.7%) hit fresh closing highs, spurred by dovish remarks from the US Federal Reserve Chairman Jerome Powell over US economy that is in remarkably good shape. Meanwhile, the pan-European Stoxx 600 added 0.4% as investors braced for an upcoming no-confidence vote in France's parliament. Asian stocks were mostly down on Wednesday, led by slump in South Korean shares after President Yoon Suk-Yeol's abrupt reversal of a short-lived martial law stirred political turmoil and eroded investor confidence across the region. Kospi fell -1.4% while Shanghai Composite dropped -0.4%.
- Market Outlook. FBM KLCI extended its momentum upwards since the start of the week as bargain hunting activities emerged. We expect the local market to extend its recovery trend ahead of the year-end window dressing. The positive developments on Wall Street overnight may provide support to the local bourse's recovery trend today. Sector wise, the Technology sector may see further buying interest, tracking the overnight gains in Nasdaq. Lower liners have shown signs of recovery in recent trading sessions. We expect small-cap stocks to attract further bargain hunting activities as traders start to adopt risk-on mode.

 Technical Commentary: The FBM KLCI formed another bullish candle as the key index build onto its previous session gains yesterday. Indicators turned positive as MACD Line floated above the Signal Line, while the RSI hooked above 50. Immediate resistance is located at 1,625. Support is envisaged around 1,570.

- Capital A Bhd's logistics arm Teleport is expected to close its financial year ending Dec 31, 2024 (FY2024) with a record-high annual revenue of more than RM1 billion, according to its chief executive officer Pete Chareonwongsak.
- **Superlon Holdings Bhd**'s net profit for the second quarter ended Oct 31, 2024 (2QFY2025) dropped 12.4% year-on-year to RM3.24 million from RM3.69 million, weighed down by higher foreign exchange losses.
- ACE Market-listed Focus Dynamics Group Bhd has proposed a share capital reduction to wipe out up to RM126.8 million of the company's accumulated losses.
- The Employees Provident Fund (EPF) has emerged as a substantial shareholder in Mega First Corporation Bhd, after raising its direct stake in the utility conglomerate company to 5.99%, comprising 56.54 million shares.
- **Uzma Bhd** has been awarded a contract by Enquest Petroleum Production Malaysia Ltd to supply hydraulic workover unit (HWU) equipment and services for Enquest's offshore East Malaysia workover campaign.
- **UEM Sunrise Bhd** has announced the resignation of its chief executive officer Sufian Abdullah, which will take effect from Feb 28, 2025.
- **Mulpha International Bhd**, which has been focusing its activities in Australia in recent years, has proposed to buy a 6.46-hectare land in New South Wales state for A\$68.09 million (RM196.78 million).
- **Central Global Bhd** said Geneva Insurance Group (Barbados) Inc has ceased to be a substantial shareholder in the construction and manufacturing company after disposing of 35 million shares, representing a 4.59% stake.
- **Apollo Food Holdings Bhd**'s net profit grew 6.7% year-on-year for the second quarter, supported by higher domestic and export sales.
- TMC Life Sciences Bhd said its suspended CEO Wan Nadiah Wan Mohd Abdullah Yaakob has been found guilty of misconduct following a domestic inquiry.
- **Sentoria Group Bhd** said it has triggered Bursa Malaysia's Practice Note 17 (PN17) criteria after its shareholders' equity fell to 33% of its issued and paid-up capital, based on its just released financial statement for the year ended Sept 30, 2024 (FY2024).
- **Binasat Communications Bhd** has proposed to undertake a private placement to finance the acquisition of several properties.
