Market Review & Outlook

Malaysia Market Review: The FBM KLCI declined by -0.15% on last Friday, snapping a four-day winning streak, as profit-taking activities emerged. Lower liners were positive, with small-cap stocks gaining interest from bargain hunting amid improved sentiment. Healthcare (+2.2%) was the top-performing sector, driven by buying interest in glove counters, while the Plantation sector (-0.5%) was the biggest laggard as profit-taking set in.

Global Markets Review: Wall Street ended on a positive note on last Friday, with the S&P 500 and Nasdaq reaching record highs, fuelled by upbeat financial forecasts from consumer companies and easing labour market data, which strengthened prospects of a Fed rate cut this month. The Dow, however, declined slightly. In Europe, markets closed higher despite political uncertainties in France. Asian markets were mixed, with investors monitoring Korea's political turmoil. The Hang Seng rebounded +1.6%, while the Nikkei and Shanghai Composite posted -0.8% and +1% performances, respectively.

Market Outlook: We expect the FBM KLCI to trade positively today, tracking Wall Street's performance. Despite the ongoing outflow of foreign funds, market sentiment has shown improvement, supported by local institutional fund buying activity and year-end window dressing. On the global front, all eyes will be on the US CPI data later this week, which will provide crucial clues about the Fed's interest rate decision this month.

Sector focus: Plantation sector may see interest return after last Friday's profit-taking, supported by elevated CPO prices while Technology sector expected to see buying interest, tracking Nasdaq's record high and Healthcare sector likely to experience profit-taking following Friday's strong gains.

Technical Commentary: The FBM KLCI formed a bearish candle to snap a four-day winning streak on last Friday. Indicators remained positive as MACD Line floated above the Signal Line, while the RSI steadied above 50. Immediate resistance is located at 1,625. Support is envisaged around 1,570.

JAKS Resources Bhd said its indirect subsidiary MNH Global Assets Management Sdn Bhd has filed for the establishment of a medium-term note (MTN) programme of up to RM250 million with the Securities Commission Malaysia.

The Employees Provident Fund (EPF) has emerged as a substantial shareholder in **KIP Real Estate Investment Trust** for the first time.

ITMAX System Bhd said on Friday it is partnering with Aim-Force Sdn Bhd to jointly develop smart parking enforcement solutions, and enterprise mobility software and technologies for various projects.

OSK Holdings Bhd's property arm, OSK Property Holdings Bhd, plans to expand its activities in Kedah with the acquisition of five parcels of plantation land totalling 330.53 acres (133.76 hectares) for RM72 million.

Kawan Food Bhd is venturing into the supply and distribution of information technology equipment via a joint venture with several individuals, including its founder cum major shareholder, and its current chairman.

Crescendo Corp Bhd is selling more land for the development of data centres in Johor, this time for RM120.06 million, cash.

Cypark Resources Bhd is partnering with the Terengganu state government to develop a 500 megawatt (MW) large hybrid hydro floating solar (HHFS) plant at Tasik Kenyir.

FSBM Holdings Bhd said it has teamed up with a US technology firm to develop a consumer-to-manufacturer (C2M) platform for the Malaysian and Southeast Asian market.

MMAG Holdings Bhd has proposed a share capital reduction to wipe out up to RM270 million of its accumulated losses.
