Technical Commentary:

After a period of consolidation, the stock turned higher in June and has since established a steady uptrend. It is now testing resistance at RM2.09, where a decisive breakout could extend gains toward the next resistance zone at **RM2.25–RM2.35**. On the downside, immediate support is pegged at **RM1.94**.

Technical Commentary:

The stock bottomed at RM0.85 in April after a brief consolidation, before staging a recovery in May and entering another sideways phase. It recently broke above resistance at RM1.23, but the appearance of a bearish reversal candle points to a possible short-term pullback. Traders should watch for a decisive breakout above **RM1.34–RM1.40** to confirm bullish momentum, with immediate support at **RM1.19**.
