## Technical Commentary:

The stock has broken out of its Triangle pattern, signalling a potential continuation of the recent uptrend. Bullish momentum remains intact, as reflected by a rising RSI and a positive MACD crossover, suggesting that prices could move higher in the near term.

**We expect prices to rise towards RM1.56, followed by RM1.75, while the stop-loss is set at RM1.37.**
