Technical Commentary:

The share price has broken above its long-term downtrend line after several weeks of consolidation, signalling improving momentum. The MACD has turned bullish with a fresh crossover, while the RSI continues to strengthen. A sustained break above the SMA200 would reinforce the bullish outlook.

We expect further upside towards **RM4.96** and **RM5.20**, while the stop-loss is set at **RM4.24**.

We expect further upside towards **RM1.24** and **RM1.32**, while the stop-loss is set at **RM1.06**.
